#### Highlights:

<u>General Information</u>. Our All Funds balance as of October 31, 2025 is \$8,422,163.64 (see page 4 of this report).

<u>Revenues</u>. In October, we received STAR Ohio interest income in the amount of \$28,159.53, and 5/3 Securities interest income in the amount of \$183.02. We also received multiple annual fee payments that amounted to \$43,602.80.

<u>Expenses</u>. The largest expense item for September was **Personnel Salaries & Benefits** in the amount of \$30,478.98.

As of October 31, 2025, we have **received 87.97%** of our budgeted annual revenues, and have **expended 92.34%** of our budgeted annual expenditures (please note the revenue % does not include any of the Bond Fund contributions, and the expended % does not include BCFA's \$1,000,000 General Fund transfer to the Bond Fund).
